CarePath Mechanism for the provision of integrated aftercare support services

Executive summary

The main goal of this document is to report and describe the implementation and function of the “D4.2.1 CarePath Mechanism for the Provision of Integrated Aftercare Support Services”. The development of this online mechanism is foreseen within **Work Package 4: CarePath mechanism for the provision of integrated aftercare support services**. In this document, we will discuss the details of the Mechanism and the functions that it offers to users.

CarePath partnership has launched the CarePath Integrated Service Provision Mechanism for relevant stakeholders and professionals working with children leaving care. The CarePath Mechanism is an online platform and includes various types of organizations, e.g. public authorities, NGOs, social services, child protection agencies and psychotherapists, healthcare, in the project countries, namely Italy, Belgium, Hungary and Greece.

The aim of the CarePath Mechanism is to facilitate stakeholders and professionals who work in the field of aftercare and with children and youth who are prepared to leave care to look for organizations relevant to their work in a more easy and efficient way.



1. Introduction

1.1. CarePath project at a glance

CarePath is a two-year EU-funded project working across four EU member states – Belgium, Greece, Hungary, and Italy. CarePath aims to provide public authorities and professionals of child protection systems with policy guidance and interdisciplinary training resources regarding the protection, rights, and development of traumatized children. Public authorities will benefit from the development of an integrated aftercare support mechanism, which will better involve the children themselves and specialized professionals in the handling of leaving care cases. Psychotherapists, art therapists, social workers, psychologists, teachers and healthcare professionals in the partners' countries will become familiar with the UNCRC methodologies and approaches, including those required for effectively listening to each child, recognizing their personality and distinct needs, and providing individual but integrated leaving care support. They will be trained to apply trauma-informed approaches to leaving care plans, and to use common standards, tools, and systems for monitoring, evaluation and reporting cases.

The project's objectives are:

- Identify transferable procedures and trauma-informed working methods in integrated child protection systems as regards leaving care support.
- Ensure that children ageing out of care have access to adequate trauma-informed aftercare support in the partners' countries, as part of an integrated child protection system.
- Increase the capacity of professionals in these systems to effectively support traumatized children, directly involving the child in determining the most suitable aftercare option for them.



- Develop a sustainable mechanism to enable public authorities and professionals to provide integrated psycho-social support services to children leaving care, based on trauma-informed interventions.

2. CarePath Mechanism for the provision of integrated aftercare support services

2.1. Content and use of the CarePath Mechanism

The CarePath Mechanism for the provision of integrated aftercare support services is included in Work Package 4 of the project titled “CarePath mechanism for the provision of integrated aftercare support services”. The CarePath Mechanism is a web-based platform which seeks to bring together relevant stakeholders and professionals who work with children and adolescents who are about to leave care settings. The transition from care settings to independent adulthood remains a thorny matter for children and youth in care settings. Once they leave these institutions, they struggle with vital aspects such as accommodation, education, employment and healthcare. The Mechanism is intended to help these audiences look for organisations that can help this crucial transition period in a more easy and efficient way.

The CarePath Mechanism includes various types of organisations, including public authorities, non-governmental organisations, social services, child protection agencies, psychotherapists psychosocial support providers and healthcare professionals. The Mechanism lists these services in the four countries of the project: Italy, Belgium, Hungary and Greece. The aim of the CarePath Mechanism is to facilitate stakeholders and professionals who work in the field of aftercare, and with children and young people who are preparing to leave care themselves.

Overall, the CarePath Mechanism embeds 289 organizations and services. More particularly:



Belgium: 71 organizations

Italy: 112 organizations

Hungary: 29 organizations

Greece: 77 organizations

Technical features

The CarePath Mechanism was technically developed by ReadLab (one of the CarePath partners from Greece) with inputs from all project partners. The Mechanism is accessible through the webpage of the project <https://carepath-project.eu/site/en/site/mechanism.html>.

The online <https://mechanism.carepath-project.eu/> is a handmade/custom dynamic website component, built with PHP 7 and MySQL. The following libraries were also used:

The collection of the data provide to CarePath partners insights on the target groups and stakeholders that visited and used the online Mechanism.

Once these fields are answered, the user is redirected to the main menu of the Mechanism. The main menu includes all necessary details and information that facilitate the user to find the proper information.

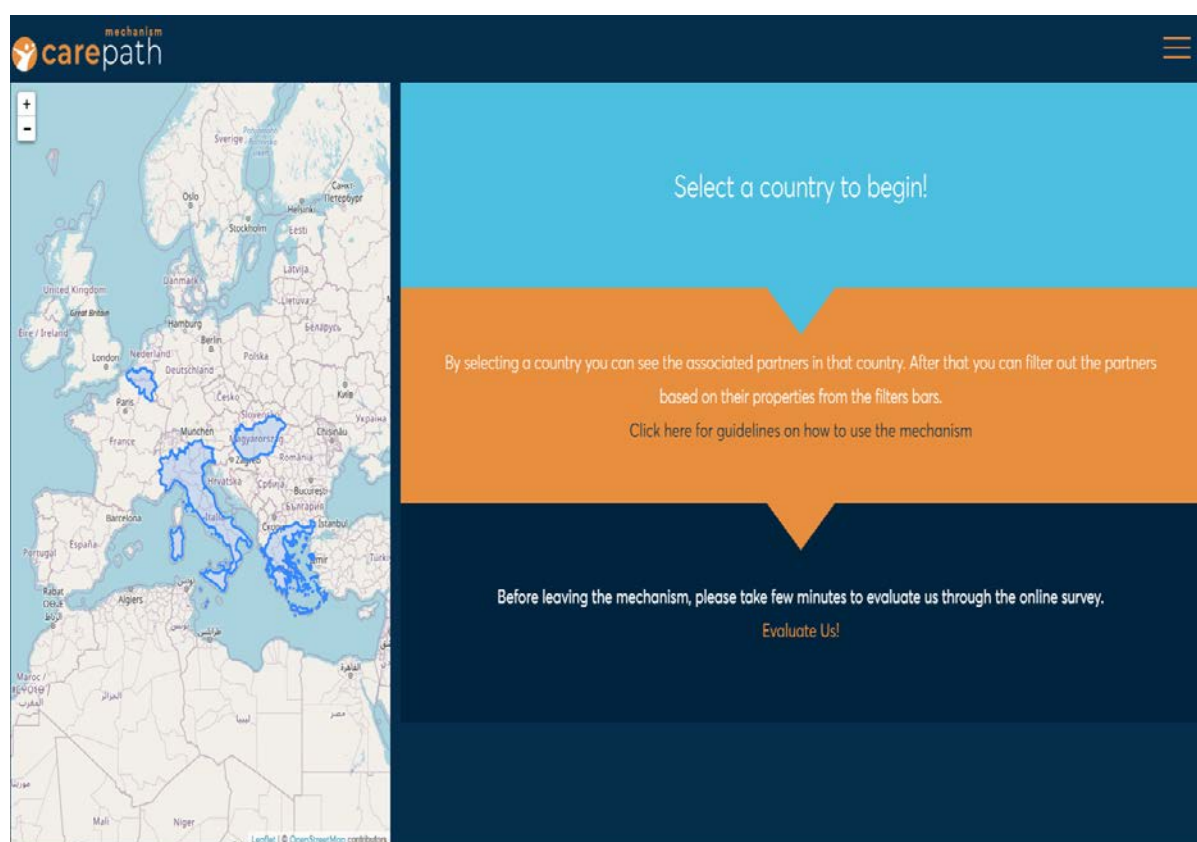


Image 2. The main menu of the CarePath Mechanism

In order to navigate through the Mechanism, the user has to choose the relevant country from the interactive map. The countries available on the CarePath mechanism are the four consortium countries, namely Italy, Belgium, Hungary and Greece. After the selection of the particular country, all relevant organizations of that country appear on the Mechanism. The following information appears per each organization:

- name of the organization/agency,
- postal address,



- email,
- phone number,
- the website of the organization/agency
- and when applicable, a short description of the organization/agency.

2.1.1. Customized search

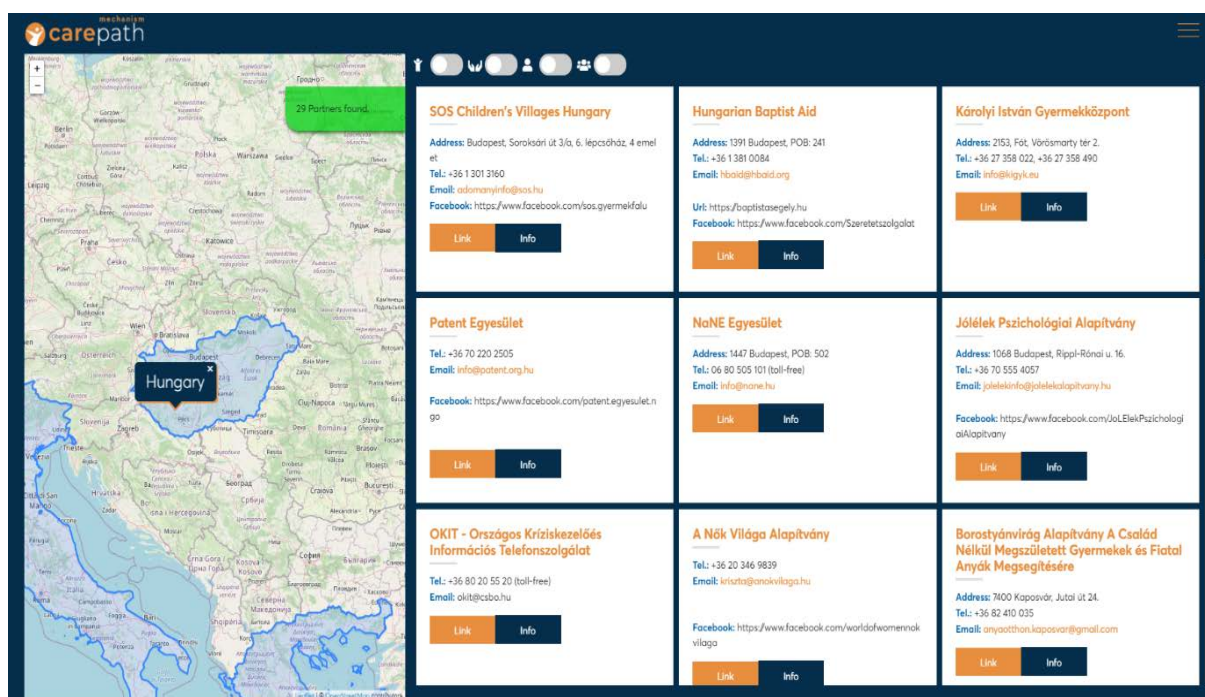


Image 4. Hungarian organizations on the CarePath Mechanism.

Given the big number of organizations and agencies included in the Mechanism, it gives the users the possibility to filter their search. On top of the page, four categories of expertise are provided: **Children, Care Leavers, Adults, Family**. The user can select more than one of the expertise and automatically the system shows subcategories allowing for further search filtering. The subcategories are: **Accommodation, Legal Aid, Psychosocial Support, Food-Personal Hygiene, Education, Immigration, Advocacy**. This customized search allows users to filter the information they are looking for.

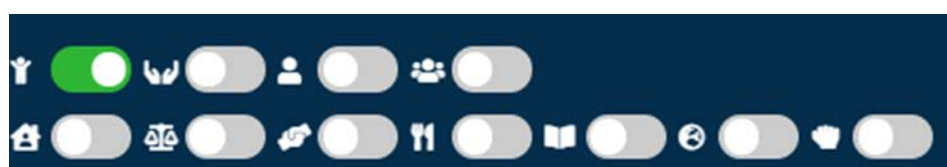


Image 5. Categories and subcategories of the CarePath Mechanism



3. Menu options

On the top right corner of the Mechanism, a hidden menu tab appears and provides information such as an about section, instructions for users, online survey and contact details. The social media account of CarePath project are also embedded in the menu tab. In that way, the menu facilitates the users to find easily and immediately the information they are looking for. The menu includes the following options:

- **Home:** redirects to the main page of the Mechanism.
- **About:** a description on the CarePath Mechanism providing the user the aim of the mechanism.
- **Instructions:** detailed guidelines and explanation for users to take into consideration before using the online Mechanism aiming to facilitate the navigation.
- **Contact:** the information of the project coordination and a contact form where users can address their questions and comments about the CarePath mechanism. The contact form can be used also by organizations/agencies from the partner countries that wish to register and include their own organisation on the Mechanism.
- **Online Survey:** an online evaluation form for users to submit and share with project partners their impressions. The survey consists of short questions and it is an important aspect of the Mechanism for project partners to receive feedback and comments which help them to improve the Mechanism and maximize its potential.



- **CarePath's social media profiles:** The online mechanism embeds Facebook, Twitter, LinkedIn and YouTube project's profiles for interested audiences who want to learn more about the project.
- **EU logo and disclaimer:** the mechanism mentions the EU funding and disclaimer.
